**SUMMER FOOD SERVICE PROGRAM**

Sodus Central School District announces its participation in the Summer Food Service Program (SFSP). Meals will be provided at all children 18 years and under without charge beginning July 12, 2021 through August 13, 2021. In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA), civil rights regulations and policies, the USDA, its agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotope, American Sign Language, etc.), should contact the agency (State or local) where they applied for benefits. Meals are also available at the following site but will be limited and served on a first-come-first-served basis for reasons of safety and security.

- Sodus Intermediate Pool (Mon. through Fri.) (12:45 p.m. – 1:00 p.m.) (Snack)

Children who participate in the 4-H Camp Beechwood program will also have the opportunity to obtain meals at the following site:

- -Beechwood State Park (7/12/21 through 7/16/21) (11:45 a.m. – 12:00 p.m.) (Lunch)

- Breakfast will be served from 7:50 a.m. to 8:50 a.m. (1 location only at this time)
- Lunches will be served from 10:30 a.m. to 12:15 p.m.
- Breakfast and Lunch from 10:30 a.m. – 12:15 p.m. (drive through only at door #7)
- Snacks will be served from 12:45 p.m. – 1:00 p.m.
