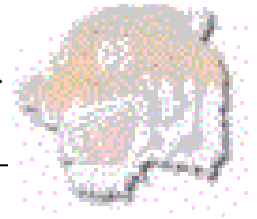

The Williamson Central School District Board of Education held its regular meeting on June 23, 2010. Under Reports from District Administrators, John Fulmer announced that the Middle School raised nearly \$1500 and with additional contributions from the senior class and Middle School Student Association, a check for \$2000 was presented to the Make-A-Wish Foundation in honor of Emma Akins. Middle school testing is complete and celebrations to highlight the end of the year have been occurring. Mr. Fulmer commented that all middle school students who took the Living Environment passed the test with flying colors and he complimented Bridget Coon for her hard work with the students. He recognized Ellen Saxby and Paula Shultes for their coordination of testing accommodations. Ellen Saxby also complimented Paula Shultes for her hard work. Miss Saxby thanked the Technology Department members Jamie Sonnevill, Miranda Foss and Jack Matthys for making her time as Technology Director a positive experience. Doug Lauf commented on the Baccalaureate and the completion of testing at the high school. Kate Taylor reported that testing at the high school went smoothly and teachers are busy grading exams and completing student grades. Wanda Miller reported that the annual reviews have been completed and she recognized Mary LeStrange and Janet Winn who will both be leaving the Special Education office. Anne Ressler stated that the UPK graduation and Flag Day at the Elementary School were wonderful events. The fourth grade visited Sea Breeze and had their graduation. The elementary students also participated in field days. Miss Ressler highlighted Tori Kolyer who has been filling in at the Main Office of the Elementary School and has done an exemplary job in the position. Wendy Havens recognized Laurie Bischoff who does a great job with many responsibilities in the Instructional Office. Gary Barno reported on deferred state aid and the bus driver appreciation breakfast. He recognized Nancy Weber and Barbara Bush for the long hours they work to make sure students are taken safely to and from school. Maria Ehresman commented that Donna Cairns has been a tremendous asset and she does a wonderful job of getting tasks done. She is creative, calm and is able to effectively diffuse situations.

A number of CSE cases were approved and Wanda Miller presented an update on the Wellness Plan with highlights from the year that included:

- A Wellness Half Day for faculty
- Breakfast for middle school students on testing days which is provided by PTSA
- Guest speakers at the high school on good decision-making and choices

Under New Business, the Board approved the following:

- Several budget transfers and the Corrective Action Plan for the Internal Audit Risk Assessment Report.
- Updated Comprehensive Safety Plan and Code of Conduct.
- Date of the reorganization meeting for July 7, 2010.
- Extension of Michael Collins as Board President and Linda Moll as Vice President through July 7, 2010.
- Abolishment of Position and Reduction in Work Force, two (2) Teaching Assistant positions, .4 School Psychologist, Networking Technician and part-time Clerk Typist due to efficiency and economy.
- Accepting a donation of \$1,100 from the PTSA to be used for Middle School Summer Camp (\$600) and a parent session with Otis Jennings (\$500).
- Approve the Resolution to adopt the 2010 Retirement Incentive Program, Part B for both TRS and ERS members.
